1. Masters in Agriculture and Rural Development is Preferable.
3. Should be able to communicate in Bengali, Hindi and English
4. Should be able to make presentation in English and Bengali
5. Should know the State Government structures and have good communication skill.
6. At least 3-5 years experience of working in rural areas for livelihoods of the rural poor community. The experience of working in climate resilience, sustainable livelihood projects is preferable.
7. The posting will be in Murshidabad district.
8. Should be able to travel within the district extensively.
9. Honorarium is Approximately Rs. 60000 per month.

The role of this position will be as follows :

- Regular interaction with District Nodal Officer (DNO) and district MGNREGS Cell for MGNREGS implementation strategy, interventions, Priority setting, focus investment like:
  - 800 watersheds having less than 30% implementation to reach 60% (300 Cr)
  - fastening implementation of 623 watersheds from current 40% to 70% (300 Cr)
  - taking 604 watersheds from current 60% to 80% (200 Cr).
- Joint field visits with District Officials to Block and field,
- Regularising District Convergence meeting, Programmes for convergence with watershed DPRs,
- Working with District Cell (Engineers, Thematic Experts) for quicker approval of schemes - AAP and SAAP,
- Regularising Block review meetings, strategy for block level troubleshooting and facilitating District Magistrate (DPC of MGNREGS) and DNO for quicker actions,
- Coordinating line departments (Forest, Agriculture, Horticulture, WRIDD especially) with DNO and Addl. District Magistrates (Development and PRI),
- Customised guidelines for GPDP and AAP and follow up and quality assessment mechanism for the district before approval,
- Strategy for priority wise (block specific) labour budget approval, priority on quality execution, tracking mechanism for at least 60% completion of new DPR interventions.
- Integrate the learning of the programme with other programmes of DRSC.
- Provide necessary training and guidance to other project area staff with regard to convergences with Government schemes and opportunities.
